Appointments Necessary at COVID-19 Testing Sites

KELOWNA / WEST KELOWNA – Residents are advised that COVID-19 rapid antigen tests are temporarily unavailable at the IH Community Collection Centres in Kelowna and West Kelowna.

COVID-19 testing by appointment continues to be available.

You can make an appointment online through the <u>COVID-19 Test Booking Form</u> 24 hours a day, or call <u>1-877-740-7747</u> for assistance between 8:00 a.m. – 7:00 p.m., PST, seven days a week.

Anyone with chest pain or difficulty breathing should not delay in seeking treatment and is advised to call their family doctor or attend their local emergency department for care.

When to get tested

A COVID-19 test is not necessary when:

- You have no symptoms, even if you are a close contact of someone who has tested positive.
- You are experiencing symptoms and can manage your illness at home. Self-isolate for five days and until you feel well enough to resume your regular activities. Notify your close contacts so they can self-monitor for symptoms.

Use the B.C. <u>COVID-19 Self-Assessment Tool</u> to determine if you need to be tested.

PCR tests are by appointment at community collection centres and are prioritized for people at higher risk including:

- People age 66 and older, regardless of COVID-19 vaccination status
- Children age four and younger
- Health-care workers
- People living in congregate settings where isolation from others (non-family members may be difficult, such as shelters or group homes

Interior Health expanding clinic availability for booster program

IH WIDE – Interior Health is expanding COVID-19 immunization clinic capacity throughout the region to make it easier for more people to get their booster dose as soon as they are eligible.

This month, larger immunization clinics are opening in Williams Lake, Kelowna, Nelson, Castlegar, Trail and Cranbrook, while clinics in several other communities are extending hours and adding more appointments at their current locations. Pharmacies across Interior Health are also adding more appointments.

"Interior Health is grateful to our community partners who are once again stepping up to provide clinic space," said Susan Brown, president and CEO of Interior Health. "With pharmacies also offering appointments, people across our region have more options to book their booster appointments as soon as they are able."

Everyone aged 18+ will receive an invitation to book their appointment for a booster dose of the COVID-19 vaccine approximately six months after the date of their second dose.

Pregnant people 18+ can get a booster dose eight weeks after their second dose. To book an appointment, they can call the call centre at 1-833-838-2323 and self-identify as pregnant. COVID-19 vaccines are safe to receive at any point in pregnancy.

"Receiving a COVID-19 booster dose is a safe and effective way to protect yourself and your community from COVID-19," said Dr. Sue Pollock, interim chief medical health officer for Interior Health. "With increased COVID-19 activity across the Interior, getting your booster dose is a critical step you can take to reduce your risk of hospitalization and to preserve capacity in the health care system."

Booster doses are by appointment only. Once you receive your invite by email or text you will be able to book your appointment. People who still need their first or second dose can drop in or also make an appointment.

Interior Health adjusting services to strengthen patient safety

IH WIDE – Interior Health is announcing temporary service adjustments to strengthen patient care due to Omicron-related COVID-19 staffing challenges.

"As we manage the Omicron-driven COVID-19 staffing impacts on the health system, Interior Health is proactively identifying services to adjust and relocate in order to maintain safe patient care," said Interior Health president and CEO, Susan Brown. "We will resume normal operations in impacted communities as soon as possible and in the meantime, we are temporarily reassigning and redeploying staff to sustain essential services throughout the region."

The temporary service changes include:

- Closing inpatient services in Clearwater, Invermere, and Lillooet to stabilize emergency departments in those communities;
- Reducing overnight hours at the Ashcroft Community Health Centre and the Slocan Community Health Centre in New Denver to stabilize daytime services in those communities;
- Closing the Barriere and District Health Centre to redeploy staff to nearby emergency departments;
- Temporarily rescheduling all non-urgent surgeries; temporarily reducing services across IH to some outpatient services; some primary care services, adult day programs and some non-urgent home health services.

Service changes will vary by community and primarily impact scheduled patients and clients who will be contacted directly. In each instance an evaluation of patient or client impacts is being reviewed as well as alternate options for care.

"Current COVID-19 pressures have lead to a staffing crisis that requires temporary emergency measures to maintain access to essential services that are relied on regionally. We regret the impacts these service adjustments may cause and will be contacting patients, clients and residents directly to address care needs wherever possible," added Brown.

- About the temporarily closed inpatient services to reassign staff and stabilize emergency departments in preparation for short-notice staff absences at: Dr. Helmcken Memorial Hospital and Health Centre in Clearwater, Invermere and District Hospital, Lillooet Hospital and Health Centre.
 - Clearwater: temporarily close six of six inpatient beds.
 - Invermere: temporarily close eight of eight inpatient beds.
 - Lillooet: temporarily close six of six inpatient beds.
- 2) About the temporarily reduced emergency department (EDs) overnight hours at the Slocan Community Health Centre in New Denver and the Ashcroft Community Health Centre to stabilize daytime staffing in preparation for short-notice staff absences.
 - Slocan Community Health Centre in New Denver: ED hours will be reduced from 24 hours to 12 hours. Until further notice its temporary hours will be 8 a.m. to 8 p.m. Anyone requiring emergency services outside these hours should call 911 or visit the Arrow Lakes Hospital in Nakusp (48 km away).
 - Ashcroft Community Health Centre: ED hours will be temporarily reduced from Friday 6 p.m. Monday 8 a.m., to Friday, 6 p.m. 10 p.m. and Saturday/Sunday 8 a.m. 8 p.m. Anyone requiring emergency services outside these hours should call 911 or visit the Royal Inland Hospital in Kamloops (97 km away).
- 3) The Barriere and District Health Centre will be temporarily closed to support staff redeployment to neighbouring communities. Anyone requiring emergency service should call 911 or visit the Dr. Helmcken Memorial Hospital and Health Centre in Clearwater (60 km away) or the Royal Inland Hospital in Kamloops (64 km away).
- 4) The temporary reduction across IH to some outpatient ambulatory clinics, some primary care services, adult day programs, and some non-urgent home health services will vary by community. Scheduled clients will be contacted directly.

Ms. Smith consulted with First Nations groups and is subsequently proposing the park be named p'a?áx Provincial Park, which is a Sinixt word meaing "healing." The Board will write a letter of support for the initiative, which will go to BC Parks for consideration.

Dear Mayors and Chairs:

Happy New Year 2022!

Thank you for taking the time to join Minister Josie Osborne and Minister Murray Rankin for the December 2021 regional meetings. As Minister Osborne and Minister Rankin said, these meetings continue to be a great opportunity to hear from you about key issues and initiatives in your communities.

The December meetings were focused on Indigenous relations and reconciliation. We very much appreciated the opportunity to hear from local governments about all the great work that is taking place to advance reconciliation and build meaningful and lasting partnerships with Indigenous communities.

Many local governments shared examples of collaboration including working together on cultural, arts and heritage projects, developing service agreements and MOUs, and incorporating Indigenous languages into signage and public spaces, to name a few. The Province acknowledges and supports the work local governments are doing to build relationships with Indigenous peoples and looks forward to hearing about future initiatives in this regard.

Inclusive Regional Governance

In the province's Draft Action Plan on the Declaration on the Rights of Indigenous Peoples Act, the Ministry of Municipal Affairs has committed to supporting inclusive regional governance by advancing Indigenous participation in regional district boards. Interest on this has been building for some time and several regional districts and First Nations are keen to see this advance. We are looking forward to engaging on this in the near future.

Other actions to support reconciliation

Given the feedback on the draft plan, government is considering other possible actions to add, to support reconciliation at the local level. The idea of working on new approaches and practices to local government name changes, in those circumstances of negative colonial context, is one of many ideas under consideration.

Finally, we heard clearly that local governments have questions on their role in supporting the implementation of the articles of the UN Declaration and the TRC calls to action, on their responsibilities with respect to DRIPA, and what that means for their evolving relationships with First Nations and Indigenous people. We are working on new guidance and encouraging the sharing of best practices you are already undertaking. We will continue to collaborate with UBCM.

Provincial State of Emergency – catastrophic flooding

The Provincial State of Emergency with respect to catastrophic flooding has been extended until end of day **January 18, 2022** due to the continued need for public safety measures under the *Emergency Program Act* and ongoing repairs to critical infrastructure.

<u>Travel restrictions</u> are currently still in place, including on Highway 1, Highway 5 (Coquihalla), and Highway 99. Note that the <u>DriveBC</u> home page is the most current source of highway conditions.

COVID 19 – Update

PHO Gatherings and Events Order – application to local governments

The December 22, 2021 Provincial Health Officer (PHO) <u>Gatherings and Events Order</u> exempts local governments (including meetings and public hearings) from the Order. It is our understanding that there is no intention for any additional restrictions for local government meetings, including restricting inperson attendance at open meetings. Accordingly, local governments can decide whether to hold electronic meetings if it is authorized in their procedure bylaw.

Local governments' decisions around electronic or in-person public attendance will depend on the unique circumstances in each community. Based on individual community needs, this could include a hybrid of virtual and in-person attendance at meetings. Local governments are encouraged to review their meeting rules and update them accordingly.

With the end of the Provincial State of Emergency, and expiration of the previous exceptional orders made under *Emergency Program Act*, no legislative authority exists to allow the Minister to issue a Ministerial Order (or any other legislative tool) to override public presence at open meetings (including providing a place for the public when electronic meetings are held). Local governments that choose to

have electronic meetings as authorized in their procedure bylaw are therefore required to provide a place for the public to attend to hear or watch meetings.

I would encourage local governments to consider enhanced safety measures where in-person attendance is required to support the health and safety of staff and the public.

COVID-19 Safety Plans

On January 7, 2022 Dr. Bonnie Henry announced an order requiring employers to re-activate their COVID-19 Safety Plans to reduce the spread of the highly transmissible Omicron variant of the COVID-19 virus. WorkSafe BC has provided guidance on reactivation or development of these plans and further information can be found <u>here</u>.

The Provincial Health Office has confirmed that a new written Workplace Safety Order will be available shortly and I will provide you with an update as soon as the new order is posted. Vaccination continues to be our primary protective measure. <u>Masks</u> continue to be mandatory for all indoor public spaces.

COVID-19 Vaccine Booster Doses

Starting in January 2022, people 18 years and older will get a booking invitation 6 months after the date of their second dose for a booster dose of the COVID-19 vaccine. Please encourage your residents to get a booster dose as this is helping to protect your communities from COVID-19.

Keep watching <u>BC's Response to COVID-19</u> website for updates, and please encourage your residents to do the same.

Infrastructure Funding

As a reminder, the intake for the ICIP Environmental Quality Program closes on **January 26, 2022**. Program information can be found at: <u>www.gov.bc.ca/Investing-in-Canada-Infrastructure-Program</u>

The Environmental Quality Program is focused on infrastructure that will support quality and management improvements for drinking water, wastewater, and stormwater. It will also support projects that remediate contaminated sites and divert solid waste from landfill.

Applicants are encouraged to consider projects that add value around environmental protection, resource recovery and reuse, climate change adaptation and mitigation and energy efficiency, generation, and recovery. A water conservation plan is a requirement for any drinking water and wastewater projects.

MO 84/2020 - Local Authorities and Essential Goods and Supplies (COVID-19) Order

On December 15, 2021 MO 84/2020 under the *COVID-19 Related Measures Act* (CRMA) was amended to repeal certain sections that are no longer necessary for current pandemic response actions and change the repeal date for the remaining sections from December 31, 2021 to December 31, 2022. Note that the sunset date for CRMA also has been extended to December 31, 2022. These changes reflect the ongoing and evolving nature of the COVID-19 pandemic.

CORPORATION OF THE CITY OF GREENWOOD

BYLAW NO. 987, 2022

A BYLAW TO ESTABLISH FEES AND CHARGES FOR SERVICES AND INFORMATION

WHEREAS the Community Charter authorizes Council to impose, by bylaw, fees and charges payable in respect of any service of the municipality;

NOW THEREFORE the Council of the Corporation of the City of Greenwood, in open meeting assembled, enacts as follows:

Citation

1. This Bylaw is cited as "Fees and Charges Bylaw No. 987, 2022".

Administration

- 2. The Corporation of the City of Greenwood imposes fees and charges for the provision of services and information as specified in the Schedule "A" attached to and forming part of this Bylaw.
- 3. Where this Bylaw sets out fees and charges with respect to other City of Greenwood bylaws and other such bylaws contain similar fees and charges, this Bylaw is deemed to prevail.

Discretionary Waiver for Public Sector Agencies

4. The fees and charges set out in Schedule "A" may be waived for public sector agencies at the discretion of an officer of the municipality.

Severability

5. If any part of this Bylaw is for any reason held invalid by a Court of competent jurisdiction, such decision does not affect the validity of the remaining portions of this Bylaw.

Repeal

6. Bylaw No. 876, 2013, cited as "Fees and Charges Bylaw", and Bylaw No. 878, 2013, cited as "Fees and Charges Amendment Bylaw", are repealed.

Effective Date

7. This Bylaw shall come into force and effect upon its adoption.
