

Back to School: From Pre-K to Post-Secondary

A look at education in the Columbia Basin-Boundary Region

Education, population health, vibrant economies, and well-being are all connected. Early learning establishes a foundation for future activities. Lifelong learning enhances personal growth and fulfillment and helps support competitiveness in today's economy.

<u>Sustainable Development Goal #4</u> is to "ensure inclusive and equitable quality education and promote lifelong learning opportunities for all." Regional education data highlight the local lens of this global goal and contribute to <u>informed policy and decision-making</u> by local governments, school districts, and post-secondary institutions.



The State of the Basin conducts analyses for five indicators of well-being related to education and learning, all of which have been updated with the most recent data available.


The Early Development Instrument shows that six out of seven school districts in the region have a lower percentage of vulnerable children than the provincial average. Student enrollment, from Kindergarten to Grade 12, is up in all Columbia Basin-Boundary school districts in 2021/22. Classroom composition shows the number of classes with four or more students with an Individual Education Plan increased in six out of seven school districts in 2021/22, while the percent of classrooms with assigned Education Assistants varies across school districts. High school completion rates increased in five of seven Columbia Basin-Boundary school districts between the 2019/20 and 2020/21 school years, but only three school districts exceeded the provincial average in 2020/21.

The COVID-19 pandemic impacted <u>college enrollment</u>, which saw a <u>decrease in the number of international students arriving in Canada</u>. However, this did not deter domestic students from continuing their education. One reason could be that post-secondary institutions <u>pivoted towards</u> online learning where they may not have offered it before.


Between the 2019/20 and 2020/21 academic years, domestic student enrollment increased in two of the four post-secondary institutions with campuses in the Columbia Basin-Boundary Region. College of the Rockies had an increase of 9%, while Selkirk College had a 4% increase. See the graphs below for domestic and international student headcounts in the 2019/20 and 2020/21 academic years.

New programming and an increase in the <u>number of seats available</u> may see changes to college enrollment in the future.

Stop guessing - drug checking saves lives

Due to several recent drug poisoning events in the region, Interior Health is urging people to use available drug checking services in order to stay safer. A region-wide <u>drug alert</u> remains in place following these toxic drug poisonings.

Interior Health has expanded drug checking services in response to the toxic drug crisis. Since being introduced in Nelson in 2018, FTIR (Fourier-Transform Infrared Spectroscopy) instruments are now available in Kamloops, Merritt, Cranbrook, Nelson, Trail, Penticton, Kelowna and Vernon. Using infrared light, these instruments can reliably detect the composition of drugs by comparing them with an extensive library of substances.

The service is fast, free, confidential and most importantly it is the only way for people to know what is in their drugs as the illicit supply continues to be tainted and unpredictable. Drug checking provides the most accurate information about what is in substances, so people who use drugs can make informed choices about where, when, and how much to use.

Drug checking is legal at approved sites. Whether someone is planning to experiment with drugs for the first time, rely on the illicit supply for pain relief, or use drugs on a regular basis and purchase from a familiar source, they are strongly encouraged to drop off a sample beforehand for testing. The technicians who provide the service are non-judgmental, and regardless of the results, drugs will not be confiscated and can be returned to you. Samples can be as small as a grain of rice, and results are typically available within 10 minutes.

In addition to FTIR testing, take home fentanyl test strips are now available in more than 72 locations throughout the region.

Quick Facts:

- Since 2019, illicit fentanyl and its analogues were involved in more than 85 per cent of illicit drug toxicity deaths.
- In 2021, 375 people in Interior Health died due to drug toxicity. In 2022 250 people have died of toxic drug poisoning in Interior Health (Jan. 1 Aug. 31).
- Fentanyl is often present in all opioid-type drugs, from pressed pills like Oxycodone and Percocet to "down" and heroin. It is also sometimes found in other drugs as well.
- 67.7 per cent of opioids checked from February to July 2022 contained benzodiazepines.
- Between July 2020 and August 2022 the benzodiazepine analog Etizolam was found in 38 per cent of illicit drug toxicity deaths.
- Benzodiazepines do not respond to naloxone and create challenges for first responders trying to reverse drug poisonings.

The British Columbia Youth Parliament will hold its 94th Parliamentary Session in Victoria at the Provincial Legislative Chambers from December 27 to 31, 2022. We are hopeful for a safe return to in-person gatherings and BCYP will follow all Provincial Public Health Guidelines.

The Youth Parliament is a province-wide non-partisan organization for young people ages 16 to 21. It teaches citizenship skills through participation in the parliamentary session in December and continuing involvement in community service activities throughout the year. Youth Parliament is a one-year commitment.

I invite you to encourage eligible youth from your municipality or region to apply to sit as members of the Youth Parliament. BCYP is non-partisan, and applicants need only be interested in learning more about the parliamentary process and in serving their community. If your municipality sponsors a "youth of the year" award or has a municipal youth council, young people with that sort of initiative and involvement are ideal candidates for BCYP.

Each applicant who is accepted to attend as a member of BCYP must pay a \$425 registration fee. Thanks to private donations and fundraising, a portion of the cost of transportation and accommodation is covered for all members. We encourage municipalities or youth councils to contribute towards the application fee for applicants who are in financial need. If the approval of financial support causes any delay, we encourage the applicant to send in their forms on time along with a note saying that the cheque will arrive after the deadline. In this case, if we receive the completed form and personal statement before the deadline, it will be considered received on time. If you are not able to aid, a limited number of bursaries are available for applicants who cannot meet the expense of the registration fee. Requesting financial assistance will not affect an applicant's chance of being selected as a member. (See https://bcyp.org/session)

Members will sit and debate in the Legislative Chambers for five days and will be accommodated for four nights at the Marriott Hotel in Victoria. During that time, participants are supervised by members of the Board of Directors of the Youth Parliament of B.C. Alumni Society and other youth parliament alumni. In addition, transportation to and from Victoria will be provided for all members who require it.

I have enclosed an application form and a brochure about BCYP. I encourage you to make the application form and brochure available to interested young people and to make copies of the forms as needed. A soft copy of the form, brochure and poster are available from our website at https://bcyp.org/session.

All application forms must be received by October 25, 2022. Selected applicants will be notified in early November. If you require more information, please contact me by e-mail as indicated above. You may also visit our website at www.bcyp.org.

WHAT IS BCYP?

British Columbia Youth Parliament (BCYP) is a youth organization that recognizes every young person's potential to lead and serve in the community. Since 1924, BCYP has provided a forum for young people to develop skills in leadership, organization, public speaking, and the parliamentary process, and to put these skills into practice through service to youth in their local communities.

BCYP is not affiliated with any political party and is a non-profit organization.

Membership in BCYP begins with attending the Parliamentary Session in Victoria and continues throughout 2023. For detailed information about BCYP's activities, visit our website, www.bcyp.org.

BCYP'S ACTIVITIES

BCYP's year begins with the Parliamentary Session from December 27 - 31, 2022. Members sit in the Legislative Assembly in Victoria and use the parliamentary style of debate to plan educational and service projects, establish BCYP's financial commitments, and amend BCYP's governing legislation. All participants must be fully vaccinated against COVID-19 to attend.

At Session, Members:

- Meet young people from all over the province;
- Debate Cabinet's legislation which sets out BCYP's activities for 2023;
- Debate current local, national, and international issues;
- Learn about debating and the rules of parliamentary procedure;
- Elect BCYP's Premier, Deputy Speaker, and Leader of the Opposition for the 95th Parliament.

After Session, Members put into action the plans made at Session, which usually include:

- Volunteer service projects in their home communities;
- Group volunteer service projects with summer camps, food banks charity walks, soup kitchens, and other service
- Special projects which vary depending on annual legislation but have included summer festivals, children's day camps and Camp Phoenix;
- Regional Youth Parliaments;
- Fundraising events;
- Social activities with other Members.

WHO CAN ATTEND?

Each year 97 youth are "elected" to BCYP as representatives of their communities. Each applicant must be nominated by an organization committed to youth (i.e. a school, community group, club, Municipality or church). Five members of that group must indicate their support by signing the application form.

To be eligible for membership you must be:

- Age 16 21 (inclusive) as of Dec. 31, 2022;
- A resident of British Columbia;
- Nominated by an organization committed to youth;
- Willing and able to participate in BCYP's activities for one year;
- Fully comply with BC's Public Health guidelines for COVID-19.

Due to the limited number of seats in the Provincial Legislature and public health guidelines, only 97 applicants will be selected to become Members this year. BCYP will follow all BC Public Health guidelines for COVID-19.

SESSIONAL ARRANGEMENTS

Accommodations: Accommodation at the Marriott Hotel Inner Harbour, Victoria is provided for all Members for the nights of December 27 – 30 (inclusive). Members will share hotel rooms. BCYP will follow all Provincial public health orders.

Transportation: Transportation for Members residing outside the Victoria area is included in the registration fee. Members living in the Interior, North, or North Island will be required to travel on December 26 and January 1.

Meals: Each Member is responsible for the cost of meals in Victoria. Some dinners will be at assigned restaurants, others free-choice.

PRE-SESSIONAL INFORMATION

The Registrar will notify all applicants by email or mail as to their acceptance status by mid-November. Accepted Members are provided with an orientation package prior to Session and are invited to attend one of the Pre-Sessional Workshops held in different regions of the province. The details of the workshops as well as travel and health & safety info will be announced in the acceptance letters.

The low carbon resilient retrofit program was has been identified as a key action in the new RDKB Climate Action Plan

The Kootenay Boundary region has 19,125 private homes with 8,176 in the RDKB electoral areas. Around 69% of the region's homes were built before 1980 when the energy efficiency requirements in the building standards were lower.

The program would include:

- Low carbon resilience guidance materials for homeowners that brings together climate mitigation, adaptation and preparedness into an easy to understand guide,

Re: The City of Greenwood's continued support of the MRDT

Further to our communications with Mayor Noll, Symphony Tourism Services as a subsidiary of the Thompson Okanagan Tourism Services has the pleasure of working on the behalf of the Regional District of Kootenay Boundary in driving tourism to this area. Included in their duties, Symphony (STS) oversees the MRDT (Municipal & Regional District Tax) and all marketing activities.

The MRDT is a tax voluntary to each individual accommodation provider to choose to remit or not. However, per the requirements of the MRDT, the province has advised that it is expecting 60% of the properties to support in the remitting of the tax, and if we fall below that amount, the continuation of the MRDT is in jeopardy.

Since initiating through STS in 2019, the MRDT has drawn around \$300,000.00 of tourism-directed funds into Greenwood and the Boundary. This has happened without a single citizen having to pay; instead, not unlike the PST, this 2% MRDT tax is applied on participating accommodation in the area. The fee is collected by the province, then sent to the RDKB who then forwards to Symphony to activate accordingly. Per the attached PDF that was used during recent stakeholder meetings — including in Greenwood — it shows that even through Covid shutdowns, the beauty of the Boundary combined with STS marketing prowess has resulted in year-over-year growth, each year since 2019. The MRDT measures in results, since it's a reflection of rooms occupied in participating hotels. This is not a metric that focuses on intent to travel or 'liking' the destination. These are hard numbers of people who took the time and their money to come to Greenwood and the Boundary.

We are asking for your help in maintaining this legacy and continuing to build tourism dollars into Greenwood & the Boundary. These are export dollars, meaning that the money isn't from your community and circulating; its new money from outside, that is brought into Greenwood.



We are reaching out to City Council, requesting that its members endorse the continuation of the MRDT by way of a letter of support. We further ask that Council uses its influence with all accommodation providers in your area, to ensure that they, too, add the MRDT to their existing remittance of PST.

Our thanks go to each of you and to Mayor Noll for your interest in the MRDT, and your intention to grow tourism to Greenwood and the greater Boundary region.

PHOENIX MOUNTAIN ALPINE SKI SOCIETY BENEFITS TO THE COMMUNITY

- With an operating season from mid-December to the end of March, we employ a total
 of 30 full-time and part-time workers. We purchase approximately 50% of our goods
 and services locally and do so whenever possible. We anticipate spending
 approximately \$100,000 at local businesses during the 2021-2022 ski season, and that
 our payroll will put another \$100,000 into the local economy all in a four (4) month
 period.
- We provide an affordable family recreational facility, 30 minutes from town, with approximately 12,000 skier visits per year. The ski hill has broad spectrum appeal with its proximity to x-country ski and snowshoeing facilities and the opportunities it offers to spectators, or those who might want to come up for lunch and a beverage.
- Our growing Nancy Greene Ski League Jr. Racing Program served approximately 25 families last year, and we anticipate an increase in participation this year with our plan to broaden the scope of the program.
- Our events, such as the NGSL zone race, draw participants from out of town, who spend an estimated \$10,000 on motels, gas and meals in Grand Forks.
- By providing every school age child in from Grand Forks, Greenwood and Christina Lake with the opportunity to learn to ski and/or snowboard, we are enhancing the physical fitness of every child in the community, at a time when physical education programs are experiencing cutbacks at the provincial and school board levels, and childhood obesity is reaching levels never before seen in our society. Each child gains from this program a new or improved physical recreational skill which they can enjoy and share with their family, in the outdoors, for the rest of their lives.
- Our Snow School learn to ski program for children ages 3 and up, and skill improvement lesson program for older children build a strong base for our Nancy Greene and School programs.
- Our free Night Ski sponsored by local businesses attracted 100 skiers and boarders this season. Many participants are new to the sport or are reacquainting themselves with it after years of winter inactivity. This is a great example of community support.
- We support community programs and events with donations of lift tickets and passes.
- We serve as a "Feeder Hill" for large resorts in the Regional District, such as Big White.

On behalf of the Boundary Invasive Species Society, I would like to thank you for financially supporting the program for so many years. We hope you will continue to financially support the program. For the 2022/23 fiscal year we are requesting \$900.00 towards the terrestrial invasive species program \$200 towards continuing the aquatic invasive species education and monitoring project that we are undertaking this year across the Boundary. We have had some challenges with Covid restrictions the past two years but were able to resume in person work this year across the region.

The terrestrial invasive plant program includes the coordination and education program that has been operating for years and involves answering public questions, web-based information, educating youth, providing management recommendations, and coordinating the treatment program for all stakeholders. To date this year, activities have included articles in local papers, facebook posts, attendance at Founder's Day and the farmers market in the west boundary.

The majority of funding the society receives is dedicated to terrestrial invasive plants, so additional funding is sought each year to enable the inclusion of aquatic invasive species information into the program. The program is a regionwide program to increase awareness in the prevention of new introductions. We have been promoting 'Don't Let It Loose' and 'Clean Drain Dry' as the main messages.

We hope you recognize the benefit of these programs to the City of Greenwood and will continue to financially support the work of the Boundary Invasive Species Society this year with the funding of \$1100 towards the invasive species program. I have enclosed a copy of our financial statement for the last fiscal year ending March 31st, 2022 and a copy of the proposed budget for the current fiscal year (2022-23), which shows our Provincial and Federal Government support being received this year. We have completed the grant in aid request form as requested.

If you have any questions or would like more information on the program please let me know. Thank you for your time, we look forward to your response. We also look forward to continuing to work with you on invasive plant and aquatic species programs.
